

## **PRIVACY STATEMENT Kremers Advocaten B.V.**

### **1. General**

In this privacy statement Kremers Advocaten B.V. provides information about the processing of personal data by Kremers Advocaten B.V., having its corporate seat at the Ginnekenweg 96 in (4818 JJ) Breda and registered in the Trade Register under number 68712804. Kremers Advocaten B.V. is the controller with regard to the personal data that are obtained or generated via the website [\[www.kremersadvocaten.nl\]](http://www.kremersadvocaten.nl), email, sms and apps.

This privacy statement applies to the visitors of the website of Kremers Advocaten B.V., the clients of Kremers Advocaten B.V. and their relations, the visitors of events of Kremers Advocaten B.V. and in addition to any and all people of whom Kremers Advocaten B.V. processes personal data, barring people employed at Kremers Advocaten B.V.

### **2. Personal data**

Examples of personal data that you supply to us are: first name, last name, address, ZIP code and place, email address and telephone number.

Examples of personal data that are generated are: IP address, surfing behavior and other data about the use of this website.

### **3. Use of personal data**

Kremers Advocaten B.V. can use your data for the following purposes:

### **4. Hiring of third parties**

## **5. Transfer outside of the EEA (European Economic Area)**

## **6. Cookies**

This website of Kremers Advocaten B.V. uses so-called functional and analytical 'cookies'. Cookies are small (text) files that are stored on your computer, tablet or smartphone when visiting a website.

These cookies are necessary to enable navigating the website. They are, however, only valid for the duration of your browser session. The analytical cookies establish how visitors use our website. With this information the use of the website is analyzed and statistics can be generated. Kremers Advocaten B.V. neither uses other Google services in combination with the Google Analytics cookies. The collected data are stored by Google on servers in the United States.
